



**Regular Village Board Meeting Minutes  
Monday, January 12, 2026– 6:00 p.m.

President Dornbrook called the meeting to order at 6:00 p.m.

Kevin Soyk led the Pledge of Allegiance.

### ***Community Updates***

An update was provided regarding Community events including the Campbellsport Fire Department Auxiliary Soup Sampler scheduled for January 17, 2026. A Campbellsport Lions Social Hour will take place at Pan and Parlor on January 27, 2026. The Annual Lake Bernice Fisheree is also expected to be held on February 7, 2026. During Citizen Input, one resident expressed concerns regarding increases to their property taxes and water billing. A second resident raised concerns about conditions on South Railroad Street near Drexel, specifically questioning liability in the event of an accident caused by nails and/or banding in the roadway. A third resident requested information on the average percentage increase in Village residents' property tax bills and also voiced concerns about construction projects remaining stagnant for extended periods of time.
