



Special Village Board Meeting
Wednesday, February 18, 2019 – 6 pm
Campbellsport Municipal Center

1 The meeting was called to order at 6:00 pm by PR Krebs. Brandon Serwe was excused from the meeting.
2 Present: Harvey, Muraski, Dornbrook, Olson, Tellier, Krebs, Hafemann, Wenzlaff, and Gruber.

4 Chapter 263, Erosion Control – Ordinance 2019-26

5 This ordinance was updated to state that the building inspector issues the permits and does inspections.
6 The penalties to be followed were set in Chapter 1, General Provisions, §1-4. **Motion made and**
7 **seconded to approve Ordinance 2019-26 with the noted changes (Muraski, Harvey). Motion carried, 5-**
8 **0. All were in favor.**

10 Chapter 192, Animals – Ordinance 2019-09

11 Additional discussion took place regarding animals in the Village. This ordinance will again be reviewed
12 at a future meeting.

14 Chapter 354, Peace and Good Order – Ordinance 2019-23

15 The sections referring to “detention” were removed. The penalties were established per Chapter 1,
16 General Provisions. The entire section after §354-16, A (1) was removed. **Motion made and seconded to**
17 **accept Ordinance 2019-23 with the changes listed above (Muraski, Harvey). Motion carried, 5-0. All**
18 **were in favor.**

20 Chapter 282, Fireworks – Ordinance 2019-20

21 Discussion took place on whether we want to allow the sale of fireworks in the Village. Class 1.4G are
22 considered Consumer Fireworks. We are unaware if any businesses have sold this or any other class of
23 fireworks, but our current ordinance prevents the sale. Chief Olson is going to research and report back
24 at a future meeting.

26 Chapter 55, Finance and Taxation – Ordinance 2019-16

27 The only change to this ordinance was allowing payroll direct deposits and employee benefits to be
28 made by ACH transactions to the Official Village Depository. **Motion was made and seconded to**
29 **approve Ordinance 2019-16 as presented (Muraski, Wenzlaff). Motion carried, 5-0. All were in favor.**

31 Chapter 228, Transient or Temporary Public Entertainment – Ordinance 2019-13

32 This ordinance will be discussed at a future meeting with Chief Dornbrook present.

34 Chapter 269, Fair Housing – Ordinance 2019-18

35 A grammatical error was corrected. **Motion was made and seconded to approve Ordinance 2019-18 as**
36 **presented (Hafemann, Harvey). Motion carried, 5-0. All were in favor.**
