Serwe arrived late. 2 3 4 Chapter 362 Property Maintenance, Ordinance 2019-24 5 This ordinance was discussed at great length but is not ready for approval. Chapter 392 Snowmobiles, Ordinance 2019-31 7 Small changes were suggested and Chief Dornbrook will check if we are bound by the Traffic Traffic 8 9 Deposit Schedule. 10 Chapter 399 Solid Waste and Recycling Management, Ordinance 2019-25 11 Discussion took place on this ordinance, but it was realized that information about chipping and leaf 12 pickup was not included, so revisions will take place for a future meeting. 13 14 Chapter 406 Stormwater Management, Ordinance 2019-32 15 Ordinance 2019-32 was adopted as presented (Hafemann, Harvey). Motion carried, 5-0 (Serwe was 16 not yet present). 17 18 19 Chapter 420 Subdivision of Land, Ordinance 2019-33 Members present were not familiar with the procedures for Village subdivisions. This ordinance will be 20 discussed when Mark Gruber is present at a meeting. 21 22 Chapter 430 Tobacco and Tobacco Products, Ordinance 2019-34 23 Motion was made and seconded to approve Ordinance 2019-34 as presented (Hafemann, Serwe). 24 25 Motion carried, 6-0. 26 Motion was made and seconded to amend Ordinance 2019-34 with the provisions of adding §§ 254.92, 27 28 134.66, and 778.25(1)(a), (Hafemann, Serwe). Motion carried, 6-0. 29 Chapter 439 Trees and Shrubs, Ordinance 2019-35 30 Motion was made and seconded to approve Ordinance 2019-34 with the declaration of Dutch Elm 31 disease, Elm Bark Beetles, Emerald Ash Borer, and Oak Wilt to be public nuisances (Serwe, Harvey). 32 33 Motion carried, 6-0.
