4 Chapter 362 Property Maintenance, Ordinance 2019-24

5 This ordinance was discussed at great length but is not ready for approval.

7 Chapter 392 Snowmobiles, Ordinance 2019-31

8 Small changes were suggested and Chief Dornbrook will check if we are bound by the Traffic Traffic  
9 Deposit Schedule.

11 Chapter 399 Solid Waste and Recycling Management, Ordinance 2019-25

12 Discussion took place on this ordinance, but it was realized that information about chipping and leaf  
13 pickup was not included, so revisions will take place for a future meeting.

15 Chapter 406 Stormwater Management, Ordinance 2019-32

16 **Ordinance 2019-32 was adopted as presented (Hafemann, Harvey). Motion carried, 5-0 (Serwe was  
17 not yet present).**

19 Chapter 420 Subdivision of Land, Ordinance 2019-33

20 Members present were not familiar with the procedures for Village subdivisions. This ordinance will be  
21 discussed when Mark Gruber is present at a meeting.

23 Chapter 430 Tobacco and Tobacco Products, Ordinance 2019-34

24 **Motion was made and seconded to approve Ordinance 2019-34 as presented (Hafemann, Serwe).  
25 Motion carried, 6-0.**

27 **Motion was made and seconded to amend Ordinance 2019-34 with the provisions of adding §§ 254.92,  
28 134.66, and 778.25(1)(a), (Hafemann, Serwe). Motion carried, 6-0.**

30 Chapter 439 Trees and Shrubs, Ordinance 2019-35

31 **Motion was made and seconded to approve Ordinance 2019-34 with the declaration of Dutch Elm  
32 disease, Elm Bark Beetles, Emerald Ash Borer, and Oak Wilt to be public nuisances (Serwe, Harvey).
